Under the FairTax, everyone takes home their entire paycheck. Also, under the FairTax, there are NO LOOPHOLES. All are taxed on what they SPEND, not on what they EARN.

To make the FairTax truly fair, the head of every LEGAL household receives a monthly family consumption allowance, the "Prebate," to offset taxes they will pay in the coming month for life's necessities, up to the poverty level.

Poverty level spending represents what it costs families of varying household size and composition to buy their necessities.
